### Administration

1. Approval of Minutes

Boos reports that IPAW's current account balance is \$19,163. Membership dues for Feb. 10 to April 5, 2011 are \$340. We now have a total of 159 current members. Renz moves to approve Treasurer's Report, Pandian seconds. Motion carries.

  - LeClair** will look into having an announcement on the WDNR website describing/linking to the IPAW bounty program. Not done. LeClair received the necessary training for adding content to the new website system, but the migration to the new website was put on hold by DNR administrators.

## New Business

### 4. Committee Reports

#### a. Anniversary/Annual Meeting Subcommittee

Boos reports that this Subcommittee met last week. Overall scope of the day is to have some kind of educational component in morning, then lunch, then Invader Crusader Awards, then Annual Meeting, then social event/activity. Will print T-shirts. Date will be Saturday, June 18, from roughly 9 a.m. to 3 p.m..

#### b. Education Committee

LeClair reports that Belle Berner has been hired as a contractor to coordinate Invasive Species Awareness Month (ISAM) and the Invader Crusader Awards (ICA). Previous grant money for ISAM 2011 is \$2,800, which will be conveyed to her through Golden Sands RC&D in Steven's Point. Doll volunteered to assist the ISAM Committee in supervising her, since IPAW will serve as fiscal agent. As part of her work, she may solicit money for 2011/2012, of which she will receive a certain percentage. There will be no poster contest this year. Bergner will coordinate the ICA, will encourage statewide partners to host ISAM events, will have some materials and web resources available for ISAM events, and will post ISAM events on the website calendar.

#### c. Website Committee

Boos reports this committee had a productive meeting recently, and included 3 new people who have not volunteered for IPAW before. A goal is to simplify the IPAW website so that it has a less cluttered front page, and is more user-friendly. The committee will focus on website structure first, then dive into content later. They hope to institute a system where individuals will adopt a webpage section (*i.e.*, review on a regular basis and provide updates as needed).

#### d. Newsletter Committee

Reinartz sent an email reminding that April 22<sup>nd</sup> is the deadline for next newsletter. The following ideas for the next newsletter were developed during brainstorming:

### 5. Future events and other announcements.

#### a. IPAW exhibit at Garden Expo 2012

LeClair reports that it costs \$100 for an exhibitor booth, including two 1-day tickets for admission, plus a max of 20 free 3-day passes. We have always missed the registration deadline, so are planning well in advance (the next Garden Expo is Feb. 10-12, 2012). We hope to have an exhibit table next to that of Wild Ones. We should also consider the possibility of doing a 45-minute seminar, demo, or workshop; proposals are due by Sept 15.

b. Farm Technology Days (FTD)

Pandian reports that FTD will be held in Marshfield on July 12-14 this year. We need more information before committing to IPAW's participation – especially fee structure. If we do participate, Pandian is willing to coordinate volunteers again.

c. NCWSS/IPAW/MIPN Conference

Renz and Doll drafted suggested negotiation points for IPAW and MIPN to take to NCWSS. The IPAW Board approved their points, which are as follows:

- i. Fifty-percent of each person's registration to the symposium will be split between IPAW and MIPN.
- ii. NCWSS will handle logistics of conference planning including, but not limited to, conference rooms, exhibit space, registration, staffing at registration booth, food/drinks at breaks and funding for keynote speakers' travel expenses.
- iii. A reduced fee will be offered for non-profit and NGO exhibitors for invasives symposium.
- iv. Opportunities for a reduced or waived admission fee will be offered to conference volunteers.

Renz and Doll also presented a proposed fee structure for the symposium, including options for a 1.5-day, 2-day and 2.5 day conference. They will present these as well to NCWSS representatives.

Feider indicates that SEWISC would like to be a non-fiscal supporting organization of this conference, hopes that members will volunteer and/or do presentations.

6. Other Business

- a. Bob Frank has resigned from the IPAW Board of Directors; he got a job in Michigan and has moved to that state. He suggested Greg Bunker as his replacement on the Board; he is a Tribal environmentalist.

**Doll** will contact Greg Bunker to inquire about his interest in serving on the IPAW Board.

- b. Betsy Popelka has resigned as IPAW Program Assistant; her job with Bicycle Federation has now been upgraded to full-time.

**Doll** will offer Katharine Brenner the job of IPAW Program Assistant; she was the hiring committee's second choice during the last interview process.

- c. The next IPAW Board meeting will be at the Annual Meeting on June 18. The next regular Board meeting will be some time in August.

**Wilkinson** will secure Room 708 at the DNR for the August meeting once we have a date.
